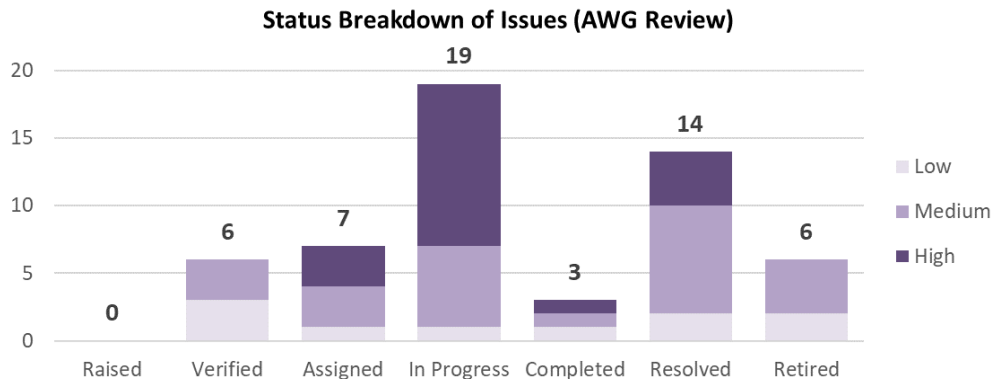

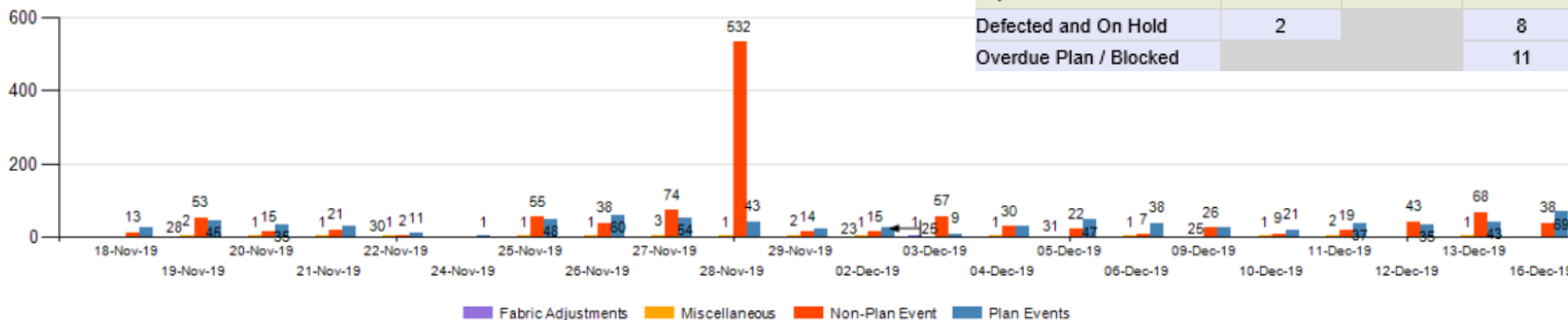

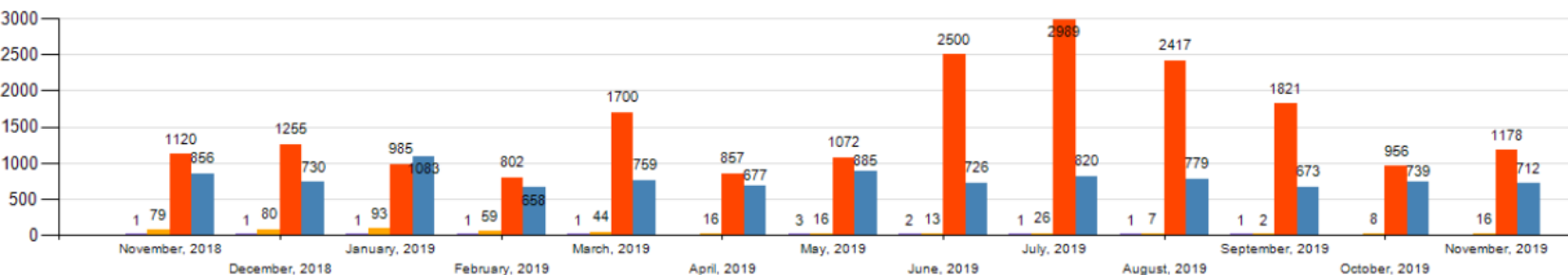

Workitem Completed Volumes - Previous 13 months

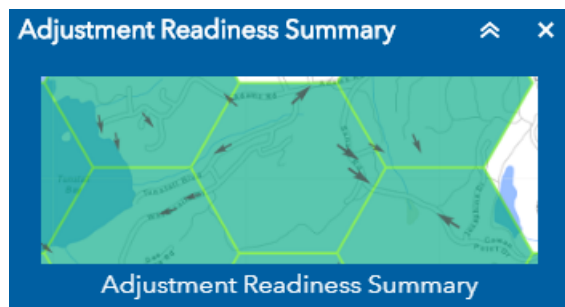

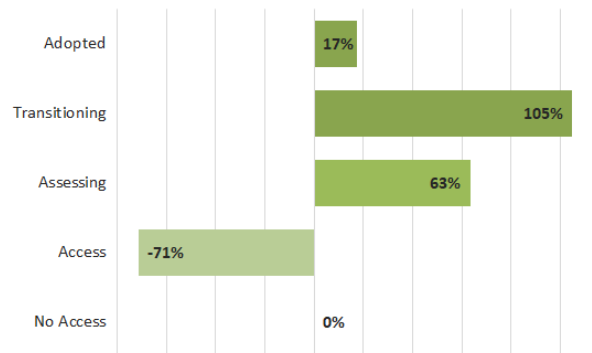

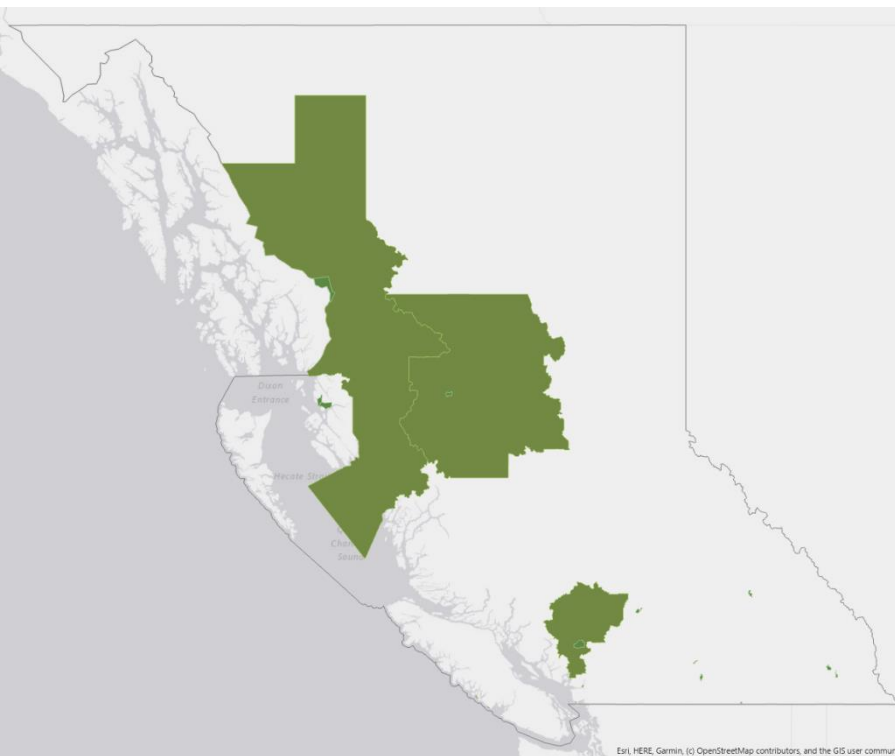

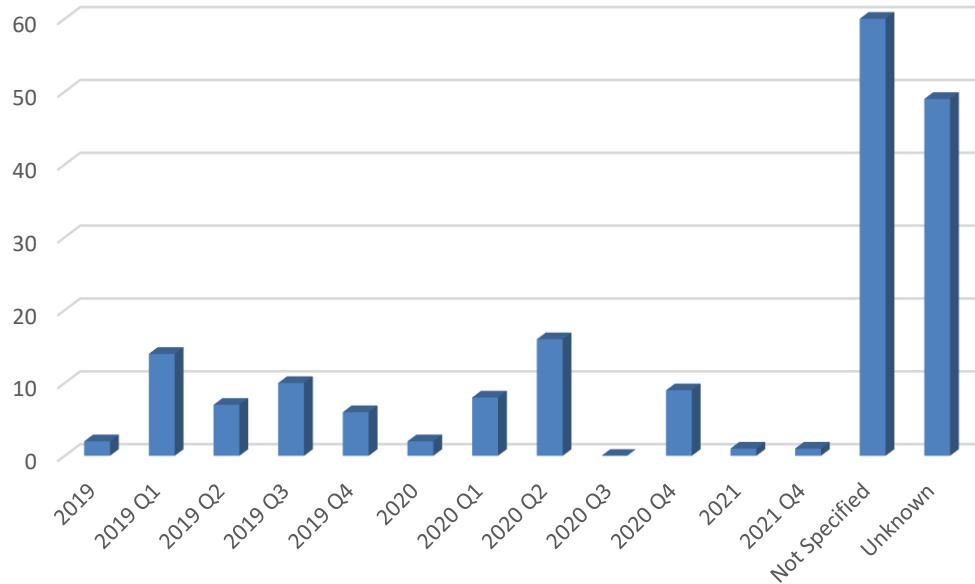

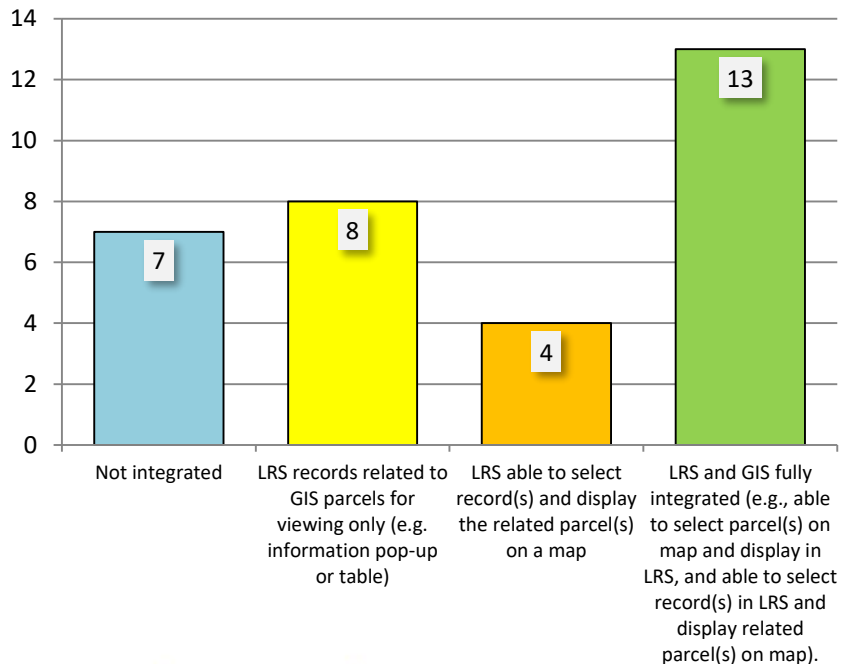

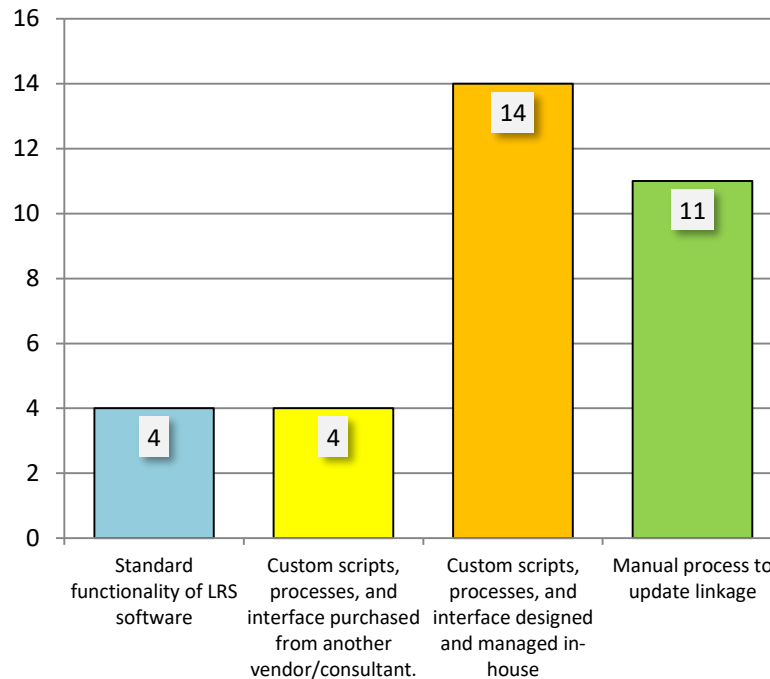

LRS Integration with GIS



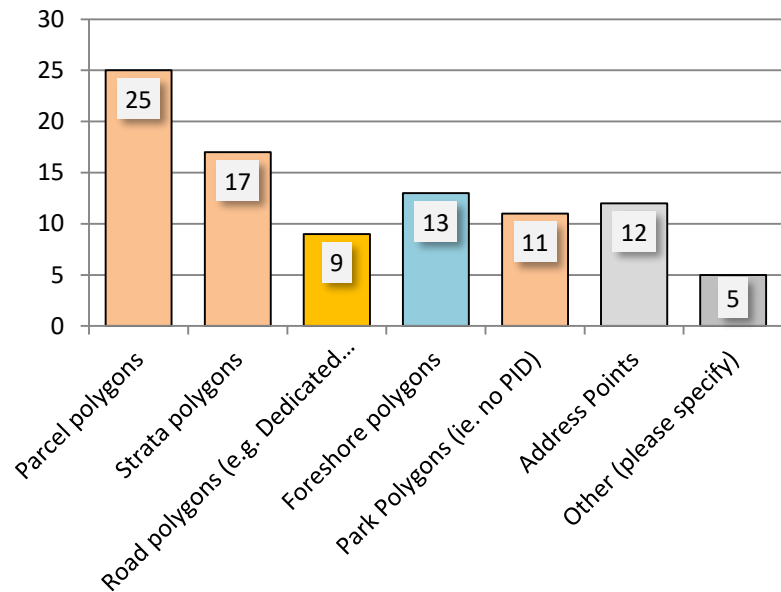
How is LRS Linkage Managed?



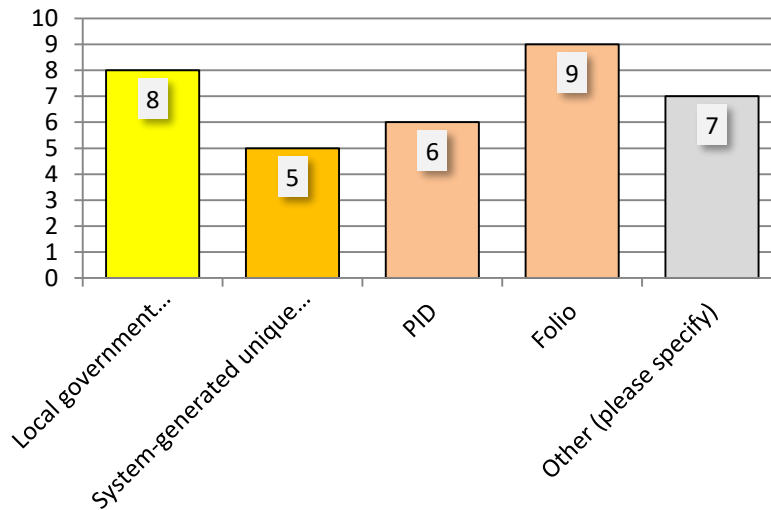

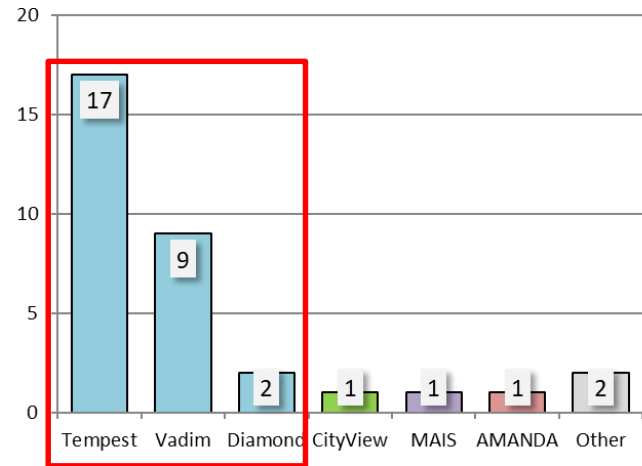


