

PMBC Adoption Working Group - Working Session #24 Summary Notes January 20, 2021 - 10:00am to 12:00pm - Web Meeting

Summary of Key Session Findings / Outcomes:

- 1. <u>Team Alignment</u>: A workshop focussing on the Alignment Tools has been tentatively scheduled for April 2021. LTSA will continue to coordinate with Esri Canada to plan this workshop and announce a date.
- Team Land Records: A workshop focussing on Land Records Integration has been tentatively scheduled for March 2021. LTSA will continue to coordinate with CentralSquare to confirm timing and scope.
- 3. <u>Team Province:</u> No specific updates from the ICF Retirement working group since the last AWG working session. DataBC's Spatial view products (Open Data and Parcel Fabric views) now include Strata PIDs in the ParcelMap BC Parcel Fabric. An ArcGIS "swipe map" has been created to assist in identifying differences between ParcelMap BC Owner Type values and ICF Ownership Class values.
- 4. <u>ParcelMap BC Operations</u>: Recent work volumes included a record number of plan events. Despite the volume, Operations are maintaining sub-one day turnaround. The current defect rate (plans that require follow up with the surveyor for clarification) is currently around 3-4%, which is considered better than industry average. Recently completed Spatial Improvement areas include West of Armstrong, Chase, Barriere. The ongoing Active Roads Parcels project is essentially on schedule, with the majority of the work to date located within the City of Vancouver.
- 5. <u>Spatial Improvement Assessment App 2.0</u>: Key features of the new application release were demonstrated to the group. The demo was very well received by the AWG who provided positive feedback during the presentation.
- 6. <u>Adopter Status Update</u>: No big changes since the last AWG Working Session. 10 new adopters so far in January (TNRD and 9 constituent LGs), which will bring the total number of Adopted to 74.
- 7. <u>ICI Society Virtual Café Summary:</u> Steve Mark provided an update on upcoming Virtual Cafes. The next session will be focussed on a ParcelMap BC "Deep Dive" and is targeted for Feb 23-25. Invitation to be sent out.

8. <u>ICI Society Member Forum:</u> Steve Mark provided a demo of the new ICI Society Forum which includes various PMBC-related Resources. Official 1.0 Release scheduled for early February.

9. AWG Participants and Current State: LTSA presented a comparison of the overall mix of Adopter Community to AWG participants by Adopter Type. Current participation in the AWG is not well aligned with overall mix of Adopter Types. In particular, LG representation is low compared to their dominance in the larger Adopter Community. There was consensus that additional large LG participation in the AWG would be desirable in the future however, to date, it has been challenging to secure their commitment to participate. One common constraint identified during the LMFG exercise was the availability of resources to apply to PMBC adoption and competing organisational priorities.

ACTION ITEM: Reintroduce the notion of resources/organisational priorities to the Issues Log – **LTSA**

ACTION ITEM: Use the upcoming workshops/Virtual Cafes as a channel to solicit LG participation in the AWG – **ICI Society/LTSA**

10. <u>Implementation Partner Updates – Esri Canada:</u> Sarah Sibbett provided a demo of the Canada Lands Parcel Mapping Data. Data update service is now running weekly and includes links now to all 3 FN Land Registry systems under a common "front end".

ACTION ITEM: Investigate making this data available via WMS/WFS – **Esri Canada**

ACTION ITEM: Add Canada Lands Parcel Mapping Data story map link to Basecamp – **Esri Canada**

11. <u>Implementation Partner Updates – Harterra Spatial Solutions:</u> Jason Hart indicated that they were seeing some uptake of ParcelMap BC for next fiscal. Requests for support are focussed primarily on planning and integration issues w/PMBC. Not much uptake thus far on the Alignment Tools. This is partly due to alignment not being a big issue for smaller LGs.

ACTION ITEM: Discuss need for additional Implementation Partners – **AWG #25**

12. Adopter Issues Log: The current state of the Issues Log will be a focus of AWG #25.
