

## PMBC Adoption Working Group - Working Session #29 Summary Notes June 16, 2021 – 10:00am to 12:00pm – Web Meeting

### Summary of Key Session Findings / Outcomes:

1. Communications Update: The PMBC Newsletter is now in “full swing” and is being released on a regular basis. AWG members who have not already subscribed can do so at: <https://ltsa.ca/contact-us/subscribe-to-ltsa-communications/#>
2. Team Alignment: A joint presentation by LTSA and Esri Canada was conducted at the Interior GIS Users’ Group (IGISUG) on June 1, 2021. The City of Kamloops and the Township of Langley provided highlights of their experiences to date with the DAWp at this session. A subsequent full-length workshop will be conducted on June 24, 2021 entitled “Deep Dive into Data Alignment with ParcelMap BC”. Sign up for this detailed workshop is available [here](#).
3. Team Land Records: No specific updates from Team Land Records. A recap of the Land Records workshop held on May 19<sup>th</sup> was scheduled for later in the agenda.
4. Team Province: No specific updates from Team Province.
5. ParcelMap BC Operations: The LTSA Ops team continues to be very busy. Expectation is that it will be very busy over the next several months due to market activity. Turnabout time remains under a day. Various AWG members indicated they are seeing similarly high levels of activity in their jurisdictions. Active Road Parcels: Work continues to be on track to meet the projected completion date of March 2022.
6. Adopter Status Update: Total number of organisations that have Adopted is currently 83. Newly Adopted organisations include Power River City.
7. LTSA Projects, Products & Services Update: The “Parcel Activity Notifier” was discussed. This is a service which notifies stakeholders when a title owner has changed. Several AWG members expressed interest in such a service.

**ACTION ITEM:** LTSA to coordinate with MoTI, Esri Canada and Harterra to develop a related business case. – **LTSA**

8. ICI Society Operations Update: The planned Virtual Café focussed on Utilities has been deferred. A focus group for Utilities is being contemplated to engage this segment of the Adopter Community.
9. Land Records Workshop Recap: There were approximately 100 attendees at the session held on May 19. BCA reported that they have had significant follow up as a result of the

session. Resources related to the session, including the session [slide deck](#) have been made available via the LTSA web site, Basecamp and the ICI Society Member Forum.

10. AWG Member Engagement: A survey was developed to explore AWG Member motivation and goals and look at alternative models for the AWG going forward. The limited responses that were received were summarised and discussed by the group.

Key points / "takeaways" from the discussion included:

- Most AWG members seem to favour a more interactive/workshop style format to a presentation/reporting style.
- Monthly meetings are a significant "ask" for some AWG members and they would favour a less frequent cadence (bi-monthly or quarterly).
- In person sessions are more effective than web meetings and the format should revert back to in person sessions as COVID restrictions allow.

**ACTION ITEM:** AWG Facilitation Team to develop a plan for moving forward including a revised ToR for the AWG and a proposed new session format / cadence. – **LTSA/ICI Society**

11. Adopter Issues Log: Several issues (35, 38, 48, 49, 54, 59, 60) were nominated to be moved to "Resolved": Issues 35, After a review of these items there was consensus that they could be marked as "Resolved".

Issue #22: between Steve and Tom at BCA coordinating on an updated Member Data Profile for the Assessment Fabric.

12. Utilities / Province Focus Groups: Do these segments of the Adopter Community require dedicated Focus Groups? Several AWG members (including Fortis BC) indicated they thought this would be beneficial going forward. ICI Society will be conducting a Board Planning session in July during which this will be explored.

13. Future AWG Working Sessions:

September AWG session timing TBD. Will be communicated prior to September.

Structure and cadence from September 2021 on will be based on the 'revised' AWG approach.
