

Adopter Dashboard: November 30th 2021 Footprint





ParcelMap BC Utilities Focus Group: Discovery Workshop

Scheduled for December 15th

Discovery exercise into the various areas where property & parcel information are used across the Utilities sector in BC

Structured around a high-level situational assessment help to identify:

- which business areas, workflows, applications and tools work with parcel and property data,
- related datasets that are combined with parcel & property data, and
- business drivers and dependencies around improving parcel & property data.

As a follow-on, select participants may participate in a "deep-dive" situation assessment resulting in a high-level transition plan

 - GeoBC & DataBC working on definition LTSA offered support







