

PMBC Adoption Working Group Steering Committee Working Session #34 Summary Notes

September 14, 2022 – 1:00 to 2:00pm – Web Meeting

Summary of Key Session Findings / Outcomes:

1. Consent Agenda Items: The following Consent Agenda Items were approved by the group:
 - Agenda for AWG #34
 - Summary Notes from AWG #33
 - Review of Action Items from AWG #33
2. Adoption Status Updates: As of August 31, 2022, 113 organisations have adopted ParcelMap BC. This represents more than 50% of the identified organisations with the Adopter community. Several other organisations, including the City of Kelowna, are making good progress toward adoption as well.
3. Team Province – ICF Retirement: The ICF has been populated using ParcelMap BC since July 5, 2022. GeoBC reports there has been little or no specific feedback to date regarding the transition.
4. Team Province – Other News: Other developments with the Province include ongoing discussions with LTSA, BCA and Municipal Affairs regarding scenarios where there is distinction to be made between title in the name of the crown vs untitled crown land.
5. Team Alignment: No major updates aside from general increased usage and uptake. LTSA is continuing to gauge interest and assess challenges associated with migrating workflows to ArcGIS Pro.
6. Team Land Records: No major activity or developments since the last AWG. Brian Goble, one of the key members of this sub-group, has moved to the City of Colwood and will be invited to continue to participate in the AWG in his new position.
7. Recent Outreach Activities: The following outreach activities occurred since the last AWG:
 - LTSA attended LGMA Annual Conference (Penticton, June 21-23) - Focus on CAO's and other LG management.
 - ESRI IUC (San Diego, July 11-15) – 5 LTSA representatives attended. CEO presented at National Government Executive Forum.
 - Interior GIS Users' Group (Virtual, July 20) – LTSA and ICI Society representation
 - MISA Fall Conference (Victoria, August 29 – September 1) – LTSA hosted a booth and ICI Soc also attended. Focus on IT leaders and LG management.

11. ParcelMap BC Fabric Operations Migration to ArcPro: LTSA's Fabric Operations team is currently working with Esri Canada to move workflows to ArcGIS Pro. This is a fundamental and complex change. LTSA plans on having the prototype complete by March 31, 2023 and will execute the formal transition next fiscal year.
